"The Company" is not responsible for the acts of third parties over whom it has no control, these third parties include, but are not limited to; governments, airlines, hotels, taxis and transportation providers, tour guides, property owners, event sponsors, and the like. "The Company" is not responsible for sickness, injury, loss of enjoyment, disappointment, disturbances, failure of transportation to arrive or depart as scheduled, refusals to issue visas, quarantines, acts of God, war, curtailments or interruption of transportation facilities, threats or acts of terrorism or similar acts, civil disturbance, or any other emergency beyond "The Company's" control.
